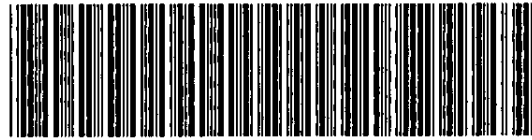




- (1). The name of the "Other Business Entity" immediately prior to the filing of this Certificate of Conversion is MDY Primary Care Medicine, P.A.
