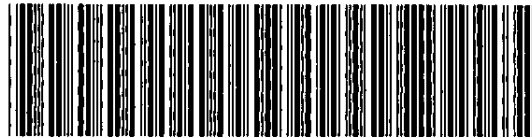

Admission of Additional Members**


