The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **PMG OF CENTRAL FLORIDA L.L.C.** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 207 Kingsway Road, Suite B, Brandon, Florida 33510 and the mailing address shall be Post Office Box 2255, Mango, Florida 33550.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




