ARTICLES OF ORGANIZATION OF VALENT CAPITAL, LLC

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

The name of the limited liability company is VALENT CAPITAL, LLC, a Florida limited liability company, (the "Company").
