ARTICLES OF ORGANIZATION OF

SUNRISE ANIMAL HOSPITAL LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a limited liability company

under the laws of the State of Florida does set forth the following:

1. NAME

The name of the limited liability company is SUNRISE ANIMAL HOSPITAL LLC (hereinafter referred to as the "Company").

2. PERIOD OF DURATION

The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:

- (i) Dissolution of the Company pursuant to the provisions of the Florida Limited
 Liability Company Act; or
- (ii) By the mutual written agreement of a majority in ownership interest of the members of the Company (each a "Member" and, collectively, the "Members"); or
- (iii) As provided for in a written Operating Agreement executed by all of the Members.
