ARTICLES OF ORGANIZATION OF SOUNDSATIONS ENTERTAINMENT, LLC



The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME AND ADDRESS

The name of the limited liability company shall be SOUNDSATIONS ENTERTAINMENT, LLC ("Company"). The principal place of business of the Company in Florida shall be 1290 N. Ridge Blvd., Apt. 1614, Clermont, Florida 34711.

ARTICLE II
