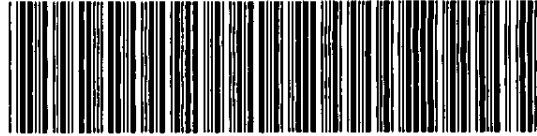

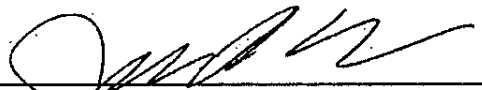

Sixth: The effective date of the Merger is December 30, 2016 at 5:00pm.

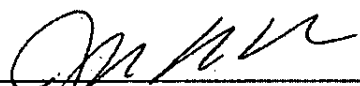
