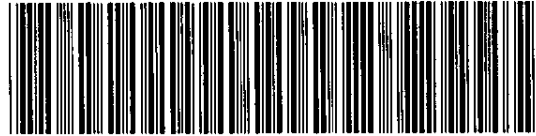

The Articles of Organization were filed on April 10, 2012 and assigned document number L12000049247.


ARTICLE II - DISSOLUTION
