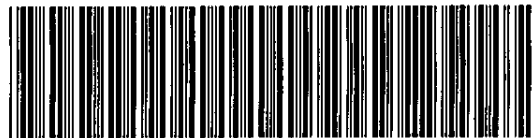

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **PLAY SKILLFUL MUSIC LLC**, ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 2620 South University Drive, #312, Davie, Florida 33328 and the mailing address shall be the same.

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.
