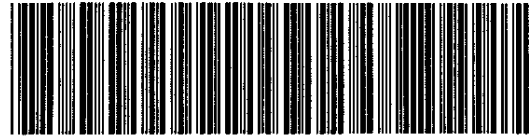

**ARTICLE I  
NAME**

**ARTICLE III  
BUSINESS, OBJECTS OR PURPOSES**

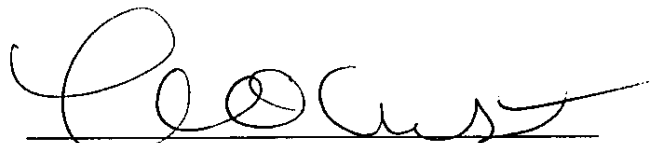
**ARTICLE VII**

**AMENDMENT OF ARTICLES OF ORGANIZATION**

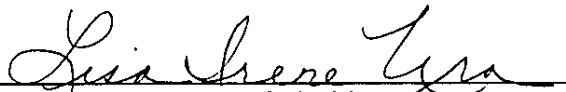
Theses Article of Organization may be amended at any time by a majority of the members of this company.

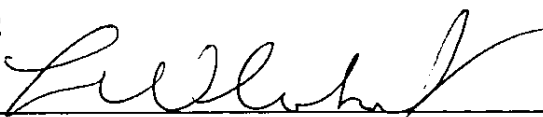
