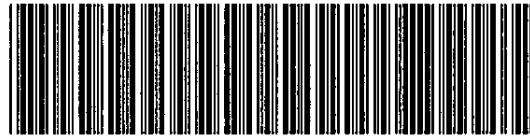

The undersigned hereby executes and acknowledges these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this company is **TRACKSPEED MOTORSPORTS, LLC.**

**ARTICLE II
PERIOD OF DURATION**

This company shall commence as of the date these Articles of Organization are filed with the Department of State of the State of Florida and shall exist perpetually thereafter, unless this company is dissolved pursuant to the terms of the operating agreement for this company or by operation of law.

**ARTICLE III
BUSINESS, OBJECTS OR PURPOSES**

The general nature of the business to be transacted by this company, or the objects or purposes of this company, shall be as follows:

a) To provide marketing, advertising, or other related services to O'Toole's Performance LLC; Trackspeedmotors, LLC; and 2TR Engineering, LLC.

b) To serve as a distributor and/or retailer of racing tires and supplies.

c) To invest in real estate, mortgages, stocks, bonds or any other type of investments.

d) To own real and personal property necessary for the rendering of the above professional services.

e) To do any and all lawful business.

f) In general, to have and exercise all powers conferred by the laws of Florida upon limited liability companies, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.


ARTICLE VII

AMENDMENT OF ARTICLES OF ORGANIZATION


Theses Article of Organization may be amended at any time by a majority of the members of this company.


