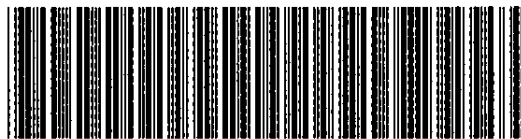

**ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is: MEDITERRANEAN NETWORK FOR BUSINESS, LLC

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 8590 Hwy 98 West, Pensacola, Florida 32516 and its mailing address is 5200 Lillian Highway #3040, Pensacola, Florida 32516, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE III
MANAGEMENT**

**ARTICLE IV
RESTRICTIONS ON MEMBERSHIP**

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

**ARTICLE V
POWERS**

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of the Company. This Article may be amended from time to time in the regulations of the Company by a unanimous vote of the members of the Company.

**ARTICLES VI
REGULATIONS**

The power to adopt, alter, amend or repeal the regulations of the Company shall be vested in the members unless vested in the manager(s) of the Company by any amendments of the Articles of Organization. Regulations adopted by the members or by the manager(s) may be repealed or altered, new regulations may be adopted by the members, and the members may prescribe in any regulations made by them that such regulation may not be altered, amended or repealed by the manager.

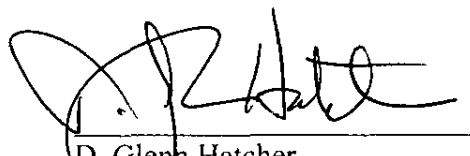

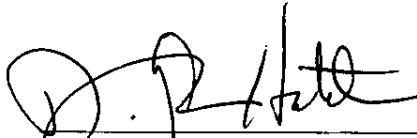
