SECRETARY OF STATE ARTICLES OF ORGANIZATION TALLAHASSEE, FLORIDA OF 3510 LANSING LOOP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be 3510 LANSING LOOP, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the initial principal office of the Company shall be 73 Burda Avenue, New City, New York 10956.

ARTICLE III - DURATION
