# ARTICLES OF ORGANIZATION OF JSMR HOLDINGS, LLC

The undersigned, desiring to form a limited liability company under and musuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the (((H12000098468 3)))

Department of State, and shall be signed and sworn to by all Member(s) of the Company.

The Company shall be managed by its Member(s).
