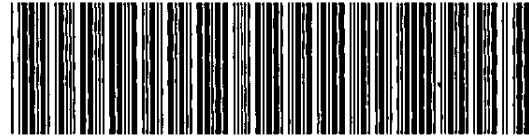


Pursuant to the provisions of the Florida Statutes, this Limited Liability Company adopts the following articles of amendment to its articles of organization:

4. The amendment of the article of organization was approved by all members on September 27, 2012. The number of votes cast for the amendment was sufficient for approval.


