ARTICLES OF ORGANIZATION OF Young Da, LLC

ARTICLE VI - INITIAL MEMBERSHIP

The return of capital and the distribution of profits shall be determined from the Company's books, as of the effective date of withdrawal, based on the provisions of the regulations, and pald as soon as practicable without diminishing the prospects of the Company's venture and subject to the Ilmitations of Florida law.

The business of the Company shall be reserved to and conducted under the exclusive management of one or more Managers according to the provisions of the operating agreement entered into between the Manager(s) and the Members of the Company.
