ARTICLES OF ORGANIZATION

ARTICLE I Name of Limited Liability Company

The name of this limited liability company is CONCORD, LLC (the "Company"), with its principal place of business being located at 24 Malvern Avenue, Somerville, Massachusetts 02144, and the mailing address is the same.

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

ARTICLE XI Certificated Interests

The members' interests in the Company shall be evidenced by certificates.

ARTICLE XII Contracting Debts

All contracting debts of the limited liability company require the approval of one of the managers.
