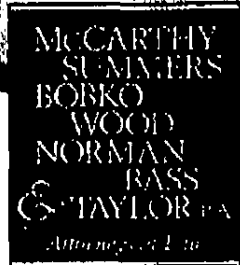

ARTICLE VI - Continuation of Business




