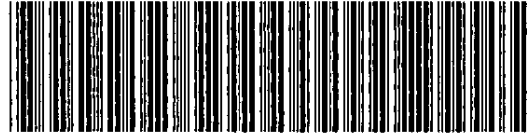




1. The name of the limited liability company is AJISAI, LLC (the "Company").
