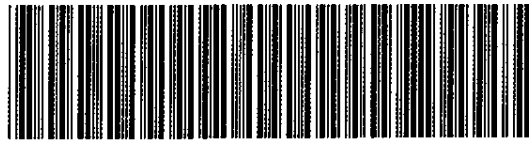



additional members.




