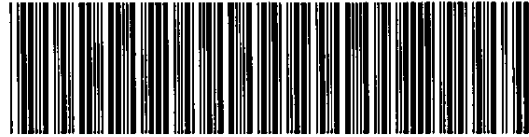

**FIRST AMENDMENT
TO THE
ARTICLES OF ORGANIZATION

1. Pursuant to §§608.411 and 608.4231, Florida Statutes, the sole member of the Company and all of the managers of the Company adopted this First Amendment to the Articles of Organization of the Company. **Section 4.02 of Article IV** of the Articles of Organization is deleted in its entirety and the following is substituted therefor:

Section 4.02. Unless changed in accordance with the Operating Agreement of the Company, the number of Managers shall be at least two (2). The initial Managers of the Company shall be Donna Brooks and Angela Brooks.

2. Except as modified hereby, the Articles of Organization of the Company shall be and remain in full force and effect.
