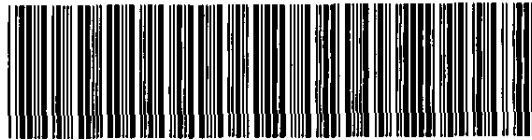

**Articles of Organization  
of

(A Florida limited liability company)

1. The name of this limited liability company is Urban Residential Properties LLC (the "Company").




