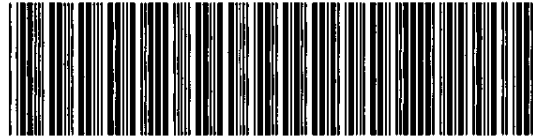



NAME
