##### Management of Business

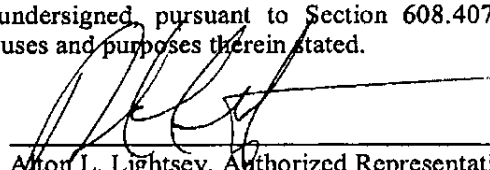

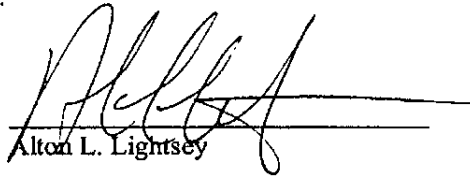
