#### ARTICLE VI - REGISTERED OFFICE AND AGENT

SECRETARY OF STATE

The Company hereby (a) designates 426 SW Commerce Boulevard, Suite 130, Lake City, Shorida LORIDA 32025 as the street address of the Company's registered office, and (b) names Scott D. Stewart as the Company's registered agent at that address to accept service of process within the State of Florida.

The Company by action of its managers, in their sole discretion, may advance indemnification expenses for actions taken in the capacity of such person as an employee or agent after receipt by the Company of (i) a written statement requesting such advance, (ii) evidence of the expenses incurred, and (iii) a written statement by or on behalf of such person agreeing to repay the advanced expenses if it is ultimately determined that such person is not entitled to be indemnified against such expenses. Absent specific action by the managers, the authority granted to the managers in this paragraph (b) shall create no rights in the persons eligible for indemnification or advancement of expenses and shall create no obligations of the Company relating thereto.
