TO THE
ARTICLES OF ORGANIZATION

The undersigned, being an authorized representative of the Member of the Company, in lieu of a special meeting, adopts the following resolution amending the Articles of Organization:

RESOLVED, that Article 1 of the Articles of Organization filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

"1. Name. The name of this limited liability company is Damascus Trading Company, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes."

RESOLVED, that Article 4 of the Articles of Organization filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

"4. Place of Business. The mailing address and street address of the Company's principal office is 14661 Double Eagle Court, Fort Myers, Florida 33912."

RESOLVED, that Article 6 of the Articles of Organization filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

"6. Management of the Company. The Company shall be managed by a manager or managers and is, therefore, a manager-managed company. Thomas M. Mouracade shall serve as the Manager of the Company."
