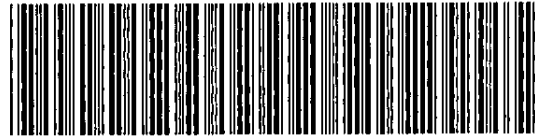

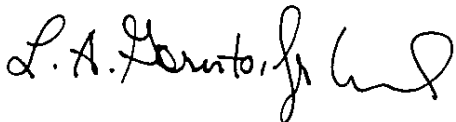

NAME

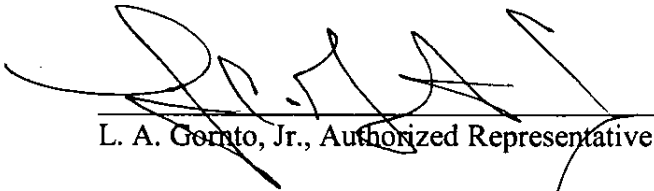

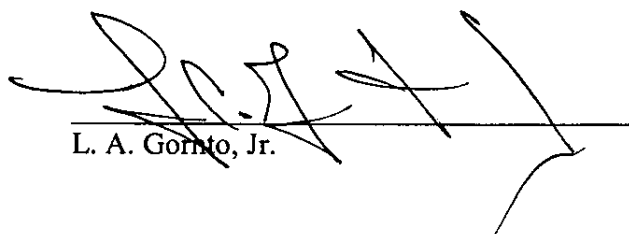
