**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Trinity Investment Holdings, LLC (the "Company"). The Company's principal address and mailing address is 206 Blanca Ave., Tampa, Florida 33606. 




**CERTIFICATE DESIGNATING
