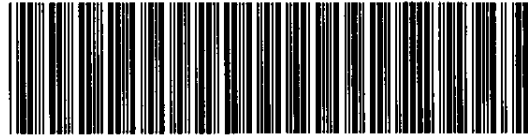

The members of the company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the Company.

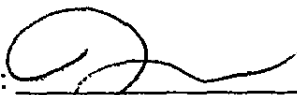
