ARTICLES OF ORGANIZATION**

Effective at 12:01 a.m. on the date of this filing, A2B Aircraft, LLC, a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, does hereby submit the following Articles of Organization pursuant to Sections 608.407 and 608.4081, *Florida Statutes*.

**ARTICLE 1  
NAME**

The name of the limited liability company shall be A2B Aircraft, LLC.

**ARTICLE 2  
DURATION**

The period of duration of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is dissolved pursuant to provisions of the Florida Limited Liability Company Act, the Articles of Organization of the Limited Liability Company, or the Operating Agreement of the Limited Liability Company.

**ARTICLE 3  
PURPOSE**
