

ARTICLES OF ORGANIZATION

OF

SEG HOLDINGS, LLC

The undersigned, acting as the organizer of SEG HOLDINGS, LLC under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is SEG HOLDINGS, LLC (the "Company").

ARTICLE II - Address:

ARTICLE III - Duration:
