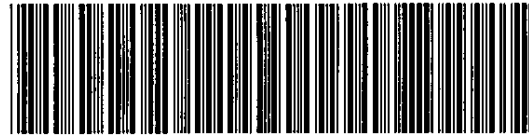

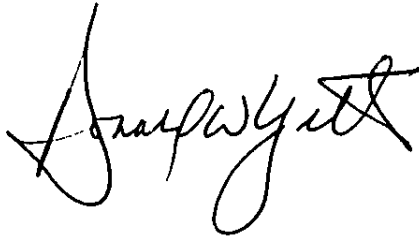

**ARTICLES OF ORGANIZATION OF**  
**4 LOTS FINANCIAL, LLC**

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **4 LOTS FINANCIAL, LLC,**

**ARTICLE II - ADDRESS**

**THE MAILING ADDRESS** and street address of the principal office of the Limited Liability Company shall be 1301 Ninth Ave West, Bradenton, Florida 34205.

**ARTICLE III - DURATION**

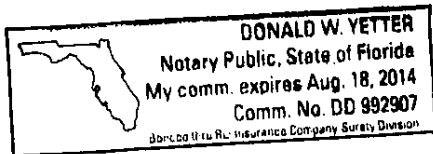

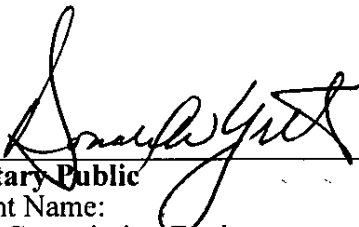
