Effective at 12:01 a.m. on the date of this filing, Classical Conversations of Fruitland Park / Lady Lake, LLC, a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, does hereby submit the following Articles of Organization pursuant to Sections 608.407 and 608.4081, *Florida Statutes*.

ARTICLE 1 NAME

ARTICLE 2 DURATION
