ARTICLES OF ORGANIZATION

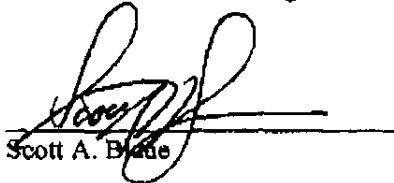
