#### ARTICLES OF ORGANIZATION

OF

### Florida Eye Specialists ASC, LLC

The undersigned person, seeking to form a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization.

- I NAME. The name of the limited liability company shall be: Florida Eye Specialists ASC, LLC ("Company").
- II ADDRESS. The initial mailing address and street address of the principal office of the Company shall be 11512 Lake Mead Avenue, Suite 534, Jacksonville, Florida 32256.
- III DURATION. The Company shall commence upon filing of these Articles of Organization with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.
- IV REGISTERED OFFICE AND AGENT. The name of the initial registered agent of the Company in the State of Florida is Rajesh Shetty, M.D. and the street address of the registered office of the Company is 11512 Lake Mead Avenue, Suite 534, Jacksonville, Florida 32256.
