ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be 1924 SANTA BARBARA BOULEVARD, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address of the initial principal office of the Company shall be 6301 Collins Avenue #1103, Miami Beach, Florida 33141. The street address of the initial principal office of the Company shall be 6301 Collins Avenue #1103, Miami Beach, Florida 33141.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. A member of the Company may withdraw from the Company only upon such terms are set forth in the Operating Agreement of the Company.

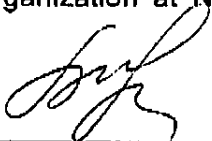

IN WITNESS WHEREOF, the undersigned organizer has made and subscribed these articles of organization at Naples, Florida, on this 15 day of May, 2012.

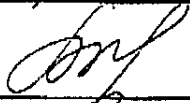
