I hereby file these Articles of Organization as the authorized representative of the member(s) of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I
NAME

The name of the limited liability company to be formed hereunder is "JHS STABLES, LLC" (the "Company").

ARTICLE II
DATE OF EXISTENCE AND PERIOD OF DURATION

The Company may engage in the transaction of any or all lawful business for which a limited liability company may be formed under the laws of the State of Florida.


ARTICLE VII

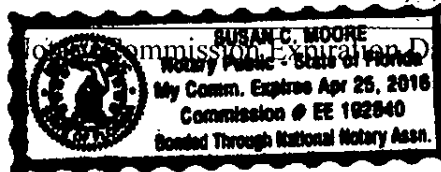

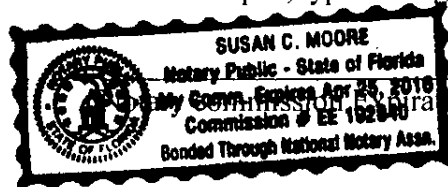
