

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

H² RESTAURANT PARTNERS, LLC

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of H² RESTAURANT PARTNERS, LLC, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, Florida Statutes § 608.411:

- 1. Name of Company. The name of the Company is H² RESTAURANT PARTNERS, LLC.
- 2. <u>Date of Filing of Articles of Organization</u>. The Company filed with the Florida Department of State Articles of Organization on May 16, 2012 (the "Articles").
- 3. <u>Amendment to Articles of Organization</u>. The first paragraph of the Company's Articles is hereby amended by deleting the current text in its entirety and substituting the following in lieu thereof:
 - "I. <u>Name</u>. The name of this limited liability company is **K RESTAURANT ENTERPRISES**, **LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida."
