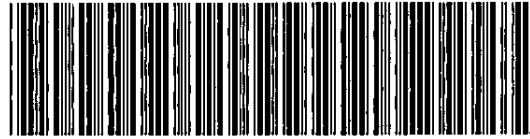

MEMBERS RIGHTS TO CONTINUE BUSINESS**



EFFECTIVE DATE AND DURATION**




