ARTICLES OF ORGANIZATION OF

THE THE STATE OF THE SHOP

<u>DEWEY GOLF, LLC</u>

<u>ARTICLE I - NAME</u>

The name of this Limited Liability Company is DEWEY GOLF, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS

ARTICLE III - DURATION
