We, hereby totally relinquish the company name, "Charlie's Grand Palace, Inc.", effective immediately and we will not request the use of this name at any time in the future.

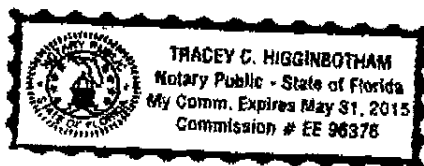
It is our intent to provide this name, "Charlie's Grand Palace, Inc.", to the new owner, Maulik D. Patel to use, if so desired, forever more.

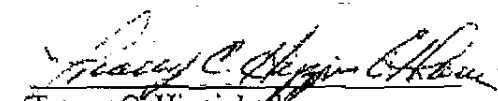
