ARTICLE V

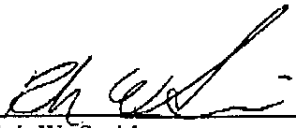

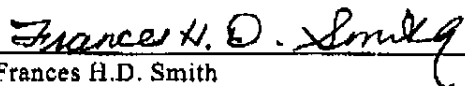

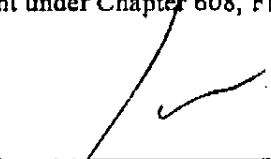
