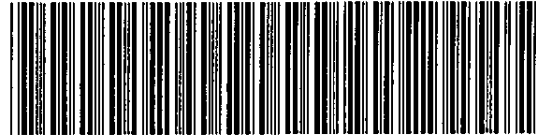



A PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Louise Hanaoka, LLC"

ARTICLE II — Address:

The mailing address and street address of the principal office of the Company is: 6210 Scott Street, Suite 116, Punta Gorda, Florida 33950.


ARTICLE III — Purposes and Powers:


ARTICLE VI — Limitation on Agency Authority of Members:

Pursuant to Section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.


ARTICLE VII — Duration:
