The Incorrect Statement is:

With the exception of ALSAT INTERNATIONAL, INC., a Florida corporation, all other parties named as managing members / managers in ARTICLE V of the ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF QUAI INVESTMENTS, LLC, filed September 4, 2012, were incorrectly included in that amendment.

The Reason the Statement is incorrect:
