ARTICLES OF ORGANIZATION OF

DISCOUNT MEDICAL LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **DISCOUNT MEDICAL LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3315 Southwest 13th Street, Suite 202, Ocala, Florida 34474 and the mailing address shall be the same.

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT




