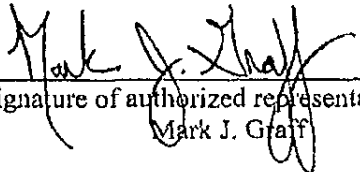
ARTICLE V

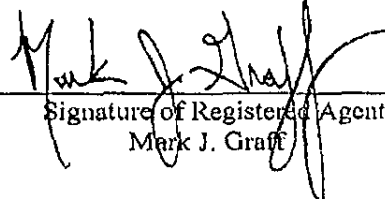
