1. Name. The name of this limited liability company is **SHORELINE MED REALTY, LLC**, a Florida limited liability company (the "Company").
2. Duration. The Company's existence shall commence on the date these Articles of Organization are filed and shall thereafter have perpetual existence.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The mailing and street address of the Company's principal office is 2905 Highway 77, Panama City, Florida 32405, Attention: Horacio Rodriguez-Jimenez, M.D.
5. Registered Agent and Office. The initial registered office of this corporation shall be located at 2905 Highway 77, Panama City, Florida 32405, and the initial registered agent of this corporation at such office shall be Horacio Rodriguez-Jimenez, M.D. The Company shall have the right to change such registered agent and such registered office from time to time, as provided by Florida law.
6. Additional Members. Additional members to the Company may be admitted in accordance with the terms of the Company's Operating Agreement.
7. Termination of a Member's Membership. The death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member or the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution.
8. Management of the Company. The Company shall be managed by a Board of Managers in accordance with the Company's Operating Agreement.
