**ARTICLES OF ORGANIZATION  
OF  
SHORELINE PHYSICIAN PARTNERS, LLC**

1. Name. The name of this limited liability company is **SHORELINE PHYSICIAN PARTNERS, LLC**, a Florida limited liability company (the "Company").
2. Duration. The Company's existence shall commence on the date these Articles of Organization are filed and shall thereafter have perpetual existence.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The mailing and street address of the Company's principal office is 2905 Highway 77, Panama City, Florida 32405, Attention: Horacio Rodriguez-Jimenez, M.D. .
