ARTICLE III - Management

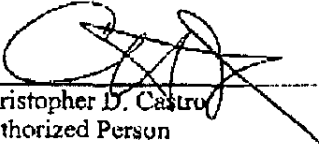

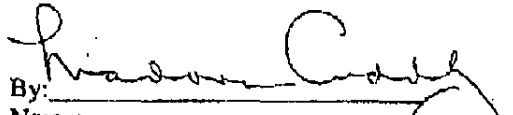
