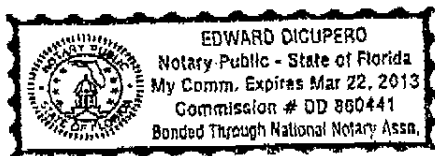
The undersigned, Robert B. Dunbar ("Affiant"), after first having been duly sworn, deposes and says:
